PLAINTIFF’S NOTICE OF ADDITIONAL DEFENDANTS

Plaintiff Sneaker Match, LLC (“Plaintiff” or “Sneaker Match”), by and through its attorneys Revision Legal, PLLC, submits the Notice of Additional Defendants.

1. Plaintiff filed this action on November 5, 2020 naming a group of defendants. ECF No. 1.
2. On November 17, 2020, Plaintiff filed a sealed Amended Complaint, Motion for Temporary Restraining Order, and Motion for Electronic Service. ECF Nos. 9, 10, and 14.
3. On November 18, 2020, this Court entered the sealed Temporary Restraining Order and granted the Plaintiff’s motions regarding electronic service. ECF Nos. 18-19.
4. On December 3, 2020, this Court granted Plaintiff’s Motion for a Preliminary Injunction. ECF No. 25.
5. The Preliminary Injunction Order entered by this Court applied to all Defendants “including known and later identified defendant aliases” identified through discovery. ECF No. 25.
6. Plaintiff issued discovery requests on several service providers in relation to the original group of Defendants identified in Plaintiff’s Complaint.

7. Through an investigation into the produced discovery, Plaintiff identified several other Defendant websites and online ecommerce stores that were infringing Plaintiff's trademark and copyright rights ("Additional Defendants") as noted on the attached **Exhibit 1**.

8. On December 15, 2020 and December 23, 2020, Plaintiff served the Additional Defendants with a copy of the Summons, Complaint, and all other papers filed in this Court consistent with this Court's November 18, 2020 Temporary Restraining Order (ECF No. 19) approving service via email and internet publication. **Exhibit 2**, Osorio Declaration.¹
